Foreword

The Alexandria Archaeology Publications series is composed of papers on various aspects of research conducted under the auspices of Alexandria Archaeology, a division of the Office of Historic Alexandria, City of Alexandria, Virginia. The authors include professional staff members, university students and Alexandria Archaeology volunteers. Editing of the papers has been kept to a minimum. It should be understood that the papers vary in tone and level of technicality, since they were originally directed toward many different audiences.

We are pleased to offer the papers within this series and in so doing are opening our "manuscripts on file" - including professional conference papers, background documentary studies, student course papers, and volunteer research papers - to professionals and public alike.

Anna Lynch began her research to identify Alexandria's earliest free African Americans in 1991. Initially we thought that this task would be time consuming, but limited in scope. Since the 1790 City Census enumerated only 52 free blacks in Alexandria, we assumed that our list of names would not reach 100. Her work fit into Alexandria Archaeology's long-term goal of locating and studying the City's first African American neighborhoods.

As Anna continued her research and located new sources, more names were accrued. The project's scope expanded beyond the first free people and neighborhoods to a large list of Alexandria's black population. This index of early African Americans actually includes the names of more than 800 people. All these people were not free, and some may not have resided within Alexandria. The early church records do not record the legal status of black members nor their addresses. Anna has included all black church members in the Baptist and Methodist Episcopal congregations in their early years regardless of whether they were free or slave, Alexandrians or Fairfax County residents. And sometimes, individuals with dates later than 1810 also appear. Thus, our scope widened because we thought that the names would be useful to other researchers and should not be omitted.

Anna's research became so prolific that we also decided that the original one volume Compendium needed to be expanded to three volumes. Thus Volume I, is an index of early African American names and facts (1787-1810). Volume II provides transcriptions of deeds and wills on some individuals listed in the first volume. Lastly, Volume III includes deed transcriptions related to the first two African American congregations in Alexandria.

Volume II provides a different perspective on Alexandria's African American population than Volume I. This volume presents a very intimate portrait of a few individuals and their families from a variety of primary sources. In some cases, the information is merely suggestive of these people's lives; but for certain individuals, such as Dominick Barecroft and William Goddard, the information is compelling.

It should be noted that information in this volume does not serve as a genealogy for anyone, nor does it include everything about an individual. Undoubtedly, more can be discovered from different sources. The volume is a wonderful compilation about Alexandria's free African Americans and their quest for freedom, family, land, homes, businesses, and the transmission of property to future generations. The lives of all people can only be understood through detailed research like Anna's.

We hope that Anna's research will open the door for others tracing their African American families or conducting thematic studies. It has certainly added immeasurably to our archaeological view of the City and helped me better understand the sites we have excavated. I gratefully acknowledge Eugene Thompson, former Director of the Alexandria Black History Resource Center, for sharing Anna's time with us. Anna is truly a volunteer who bridges the gap between museums, between cultures and between times.

Dominie Barcrofts was a large, magesterial looking negro man, partly disabled by the gout, a native of the lower counties of Virginia. Very dignified, he knew his place and his vocation and never went beyond either.

He said his proper name was Dominick Bearcroft. His specialty was crabs. He kept a licensed public house visited only by respectable persons. He came from crab country and knew how to "devil," "boil" and prepare crab soup. Epicures, titled and distinguished, from Washington would often come for crab suppers at "Dominie's."

He lived in one of those old time, half tumble down, London alley tenements.

Subject, however to payment of rent of 150 dollars on May 1st every year, rent to cease by the payment of 1500 dollars and all arrears and whereas Domini B. paid aforesaid during his lifetime to Peter Sherron, having D.B. devised the said tenement and lot of ground to his two sons William Henry and Ephriam Bearcroft party hereto; and said William Henry by deed dated 18th of December conveyed his undivided moiety thereof to the said James E. Mankin. Now this Indenture witnesses that the said Eleanor Sherron for sum of \$1 to her paid by James E. Mankin and Ephriam Bearcroft, does hereby forever release and discharge the said James E. Mankin and Ephriam Bearcroft and their heirs and assigns from the payment of the rent aforesaid and of all arrears thereof.

Stella Brannum is a dark mulatto, about 45 years-old, 5 feet 2 3/4 inches tall, with a scar on her forehead and another on her right hand. She was emancipated by George W. P. Custis since 1806.

Item. I give devise and bequeath to my brother John Goddard his heirs and assigns forever thirty feet front on the Northwest Corner of the lot I purchased of Thomas Cook and one hundred and twenty three feet five inches deep and the balance of the said lot I give and devise equally between my wife and my son William Goddard and Spenser (sic) Gray, John Campbell, James Campbell and Matilda Dilcha and their heirs forever.

Item. I give and bequeath to my son William Goddard my black Colt and a small buffaloe cow.

Item. I direct that a negro girl named Betsy I purchased of Reuben Dye shall be emancipated when she pays my estate three hundred dollars and the said Girl is to live with her mother until the said sum of three hundred dollars is paid and if her mother dies then the said girl is to return to my family to live with them until the said money is paid - which money is

to be applied to the support of my family.

And all the rest and residue of my property real and personal I give and bequeath to my wife subject to the Conditions of the first bequest - except a negro woman named Annacha Ager, the wife of Sam Ager who is to be emancipated immediately upon my death, she paying my wife sixty dollars to be applied to the support of my family.

Lastly I nominate and appoint my friends Spencer Gray and Thomas Lawrason executors of this my last Will and Testament. In witness whereof I have hereunto set my hands and seal this 7th day of December 1815.

Many of the slaves along Royal were related to Philip and Catherine Hamilton, and most were owned by the Herbert family of Alexandria. Philip Hamilton, who lived at the home of Monica Bell in 1825 (424 S. Royal), was "a slave to Colin Auld," but by 1827 he was free. Never listed as anything other than a laborer, Hamilton was still able to leave considerable real estate to his family in 1863, which included his house at 410 South Royal. His wife, Catherine, was listed as a renter in this same house from 1819 to 1841, thus, they apparently lived apart. In 1820, William Roberts emancipated Catherine whom he described as "my slave and my sister." Roberts, a free black engaged in "manufacturing" lived next door at 412 Royal. Catherine's children, Ellen and Prince, were both slaves to Mrs. Herbert in 1824 and 1825.

Hannah Jackson was also Catherine Hamilton's neighbor on the lot immediately north.

Note: In the 1825 Alexandria tax records, Hamilton appears as a slave of Edward Pleasants, living in Pleasants' house and lot on Royal Street.

I, Pompey Pohra Harris of Alexandria in the District of Columbia being at this time weak of body but of sound and disposing mind and memory and considering the certainty of death.....make and publish this my last will and testament.

First. I desire that my body may be decently buried and after my funeral expenses are paid and my just debts be paid (if any there be against me) out of such money belonging to me as may be in the hands of Edward Stabler for safe keeping and after these objects shall have been accomplished it is my will and desire that 10 dollars of the residue of said money shall be given to my wife Lucy or her representatives and in consideration that it was through the industry and frugality principally of my former wife Rose that I was enabled to lay up money...it is my desire that after the payment of aforesaid the remainder of such money be it more or less shall be for the use of the daughter of said Rose, Betty Sandford who not being free it shall be used for her benefit at the discretion of Edward Stabler in whose hands it now is.

Item. I give to my wife Lucy a cupboard Desk bed and bedding.

Item. I leave my clothes and 2 chests to be divided at the discretion of my executors between the children of Betty Sandford, stepdaughter beforementioned, and my nephew Sam Reeler.

Item. I give unto Betty Sandford above mentioned a large Black Walnut table.

Item. All the rest of my personal property I give and bequeath to my wife Lucy.

Item. The house in which I live in on Alfred Street I leave to my wife Lucy for her use and for during the term of her natural life or Widowhood, provided she regularly pay up the annual rent of 20 dollars for which the lot is bound to Mr. James Lawrason, provided also that if my Stepdaughter Betty Sandford shall become free and want a place to dwell, she shall be entitled to the use of said house and in that case paying ½ of the ground rent.

Item. Upon the death of my wife Lucy or if she should marry again or fail to pay up the ground rent, the House shall revert to my nephew Sam Reeler for his use forever provided nevertheless that the said house and lot shall be bound for the payment of 10 dollars every year for the use of Betty Sandford my stepdaughter.

Lastly, I appoint Edward Stabler and William Stabler his son as sole executors of this my will and testament. In testimony whereof I have hereunto set my hand and affixed my seal this twenty-eighth day of May in the year of our Lord one thousand eight hundred and twenty-one.

Beginning on the East side of Royal Street 112 feet 6 inches south of Wolfe Street and at the South line of Catharine Hamilton's lot and running Southerly with Royal Street 20 feet then east parallel to Wolfe Street 100 and 3/4 feet then northerly parallel to Royal Street 20 feet, then with a straight line to the beginning which rent was reserved on the conveyance of said lot by Mordecai Miller to William Roberts and was allotted to the said Robert H. Miller in the partition of the real estate of the said Mordecai Miller, his father, made by deed of August 12, 1833 to hold to the said Reuben Johnston forever. In trust, however, for the sole and exclusive use of Mary Savoy, the wife of William Savoy, free from the debts, influence, power, or control of her present or any future husband if she were a femme sole [sic] and unmarried, with power to her to receive and enforce payment thereof, by all lawful ways and means whatsoever, and also to dispose of the same as she may deem proper by ded, will or letter of appointment and in case she shall depart this life without making such disposition thereof, then the same to be held in trust for her children

and their descendants if any be then living, and in default of such children or descendants, then in trust for her right heirs.

Across the Fence, But A World Apart p. 27

William was the first free Black to live on the Coleman property. He was 22 years old in 1823-1824 and a free born dark mulatto who was probably unmarried at that time. In 1830 he was reported to live in Ward Two with Mary, his wife and one young child. By 1839 they had moved back to Royal Street and rented from R. H. Miller. In none of the censuses was William's occupation reported. Mary, a free born black is listed as a grocer in 1860. In 1851, Reuben Johnston bought Mary's lot from Miller for \$300 to be held in trust for Mary and her descendants. The lot was for Mary's "exclusive use...free from debts, influence, power, or control of her present or any future husband" and that she could dispose of it as she deemed proper. By 1858 she was assessed for furniture valued at \$50. In 1871 she purchased an adjoining back lot from R.H.Miller for \$125. She died in 1884. One of her children was a girl named Laura Virginia.

The said Nancy Cole agrees that her two sons one named John Cole fifteen years old on the 11th of this month and the other named William Cole twelve years old on the twenty seventh of december shall serve said William Wemms until the age of twenty one years or until the said Ann Cole and her husband Daniel Taylor, the slave of the said William Wemms shall pay his heirs, executors and or administrators of said Wemms two hundred and thirty dollars with interest either by installments or otherwise the said two boys are to be discharged from the service of said William Wemms and said Daniel Taylor shall remain in town of Alexandria with his wife and children as he has done heretofore to assist his wife in raising the money and by this agreement the two boys are to be employed by the said William Wemms in the County of Alexandria, his executors and administrators and not to be carried out of the county and the hire of the boys to be applied to the discharge of the said two hundred and thirty dollars and interest and said Nancy Cole doth agree that her said two sons shall during the time aforesaid and for purpose aforesaid be at the disposal of said William Wemms, his executors and administrators.

These facts are certified by affidavit of John Cole and Daniel Taylor.

Rebecca Cole Clark formerly Rebecca Cole is the daughter of Nancy Cole, a free woman of color. Rebecca will be 24 on next 24 August, is of bright dark color, and about 5 feet 1 inch tall. She has resided in Alexandria more than 18 years. Facts are certified by John Cole and Daniel Taylor.
